This is with reference to Sardar Bahadur Khan Women's University, Quetta's Tender Notice published in daily "Jang" on 30<sup>th</sup> January, 2016. It is observed that the advertisement is in violation of the BPPRA Rules 2014.


In the advertisement, only the last date and time of the opening of tender is mentioned whereas it should also include the date and time of submission of tender that shall be on the same day. Therefore the advertisement is in violation of BPPRA Rules 2014, Rule No. 33 (1). Stated as under;

*33. Opening of Bids. — (1) The date for opening of bids and the last date for the submission of bids shall be the same, as given in the bidding documents and in the Notice Inviting Tender.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
