for Repair of Official Vehicles.**

Dear Sir,

This is with reference to Balochistan Development Authority, Quetta's Quotation Notice published in daily "Jang" on 27<sup>th</sup> January, 2018. It is observed that the advertisement is in violation of the Balochistan Public Procurement Rules 2014.

As per advertisement, "The BDA reserve the right to accept or reject any quotation without assigning any reason thereof without liable for any claim dispute the decision of competent authority shall be final and shall not be challenged." It is violation of BPPRA Rules 2014, Rule No. 40. Stated as under;

***40. Announcement of evaluation reports.— (1) Procuring Agencies shall announce and upload on Authority's web the results of bid evaluation in the form of a report giving justification for acceptance of lowest evaluated bid, and reasons for non-acceptance of all other bids or rejection of each bid at least ten days prior to the award of procurement contract.***

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.
