Office of Deputy Commissioner, Buleda Road (New Alignment), Balochistan's Tender
Notice for Balance Work of Turbat Buleda Road.**

Dear Sir,

This is with reference to Office of Deputy Commissioner, Mekran Division's Tender Notice published in daily "Jang" on 28th July, 2018. It is observed that the advertisement is in violation of the BPPRA Rules 2014.

As per advertisement, the tender fee under is charged as PRs 10,000/-, which appears costly in light of the BPPRA Rules 2014, Rule No. 26(2). Stated as under;

26. Provision of Bidding Documents. — (2) The Procuring Agency may charge a fee for bidding documents, which shall not exceed the cost of preparation and printing.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
