SUBJECT: VOILATION OF BALOCHISTAN PROCUREMENT RULES 2014 PRINCIPAL CADET COLLEGE KILLA SAIFULLA'S TENDER NOTICE FOR SUPPLY OF ROTI, NAN PLANT MACHINE.

1. Kindly refer to your letter No.TLI5/285/2A dated 28th May, 2015 on the subject captioned above and to state that the reffered letter has been received in this office dated 27th June, 2015 after a long period of almost one month (copy enclosed). In said period the process of procurement has been completed.
2. The advertisement was published according to previous rules in practice before implementation of BPPRA, 2014, as no such rules were conveyed to this office earlier. A letter NO.SO (Budget) CH&TE /14-1/2014-15/1829-43, dated 11th June, 2015 regarding "Documents/Information Relating To Tenders Uploaded On B-PPRA Website" from Secretary Colleges H&T Education being a controlling authority of cadet colleges for implementation was conveyed to this office dated 27th June, 2015 after the purchase of Roti/Nan Plant.
3. The B-PPRA, 2014 rules were not observed fully due to the lack of information and communication services. This was only that the college is facing hardles for any sort of communication as no internet, land line phone, fax services was provided and courier services delivered the posts/dock after a long period of 30 to 45 days. Your organization letter is one of the precedent. Moreover, recently (15) days before telephone exchange is installed in the college which is also not fully functional.
4. Therefore, it is stated that this office will fully observe the rules and regulations in future for procurement process please.

This is with reference to Cadet College Qila Saifullah's Tender Notice published in daily "Express" on 23rd May, 2015. It is observed that the advertisement is in violation of the Balochistan Public Procurement Rules 2014.

As per the advertisement, it is mentioned that, "The undersigned shall reserve the right to reject any one or all tenders without assigning any reasons". It is violation of Balochistan Public Procurement Rules 2014, Rule No. 40. The Rule is quoted below for your reference;


40. Announcement of evaluation reports.— (1) Procuring Agencies shall announce and upload on Authority's web the results of bid evaluation in the form of a report giving justification for acceptance of lowest evaluated bid, and reasons for non-acceptance of all other bids or rejection of each bid at least ten days prior to the award of procurement contract.

Provided that a copy of the evaluation report shall be provided to any bidder who may request for the same.

The above information is forwarded for the purpose of avoiding the mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.


