RULES 2014 FOR TENDER OF CCTV CAMERAS WITH
ACCESSORIES**

The undersigned is directed to refer to your office letter No. TL 19/1605/2A dated 16th May-2019 and to state that this Secretariat follows all the rules and regulation as prescribed under the Balochistan Public Procurement Authority Rules 2014 with utmost compliance.

2. The tender for procurement of CCTV Cameras with accessories for Islamabad Annexe was processed according to the BPPRA rules 2014. The said tender was uploaded on BBPRA website on 7th May-2019 and 15 (fifteen) days response time was given from publication of Tender Notice on BBRA website (copy enclosed). Similarly, on the same date Notice for Inviting Tender was forwarded to Director General, Public Relations to publish the same in the leading dailies on 7th May-2019 (copy of the letter enclosed). However, to their dismay, the advertisement was delayed by the Directorate of Public Relations for 03 (three) days despite several verbal reminders and it was published in Daily "Jang" on 11th May-2019 instead of 8th May-2019. 3. This Secretariat has always maintained fairness in inviting tenders and abide by all the rules as depicted in the BBPRA Rules-2014 to avoid any misprocurement. Moreover, the said process was carried out after completion of all codal formalities through BPPRA website.
