Sub: Violation of Balochistan Public Procurement Rules 2014, Executive Engineer-II, B & R Provincial, Quetta's Tender Notice for Construction Works.

Dear Sir,

This is with reference to B & R Provincial, Quetta's Tender Notice published in daily "Dawn" on 25th September, 2015. It is observed that the advertisement is in violation of the BPPRA Rules 2014.

1. As per advertisement, "no information regarding issuance of tender documents is given for bidders and has just mentioned that to obtain any information may contact the office of the undersigned", which is violation of BPPRA Rules 2014, Rule No. 26 (1). Stated as under;

26. Provision of Bidding Documents. — (1) The Procuring Agency shall provide the bidding documents to all interested bidders in accordance with the procedures and requirements specified in the Notice Inviting Tender.

2. Also, it is mentioned that, "The undersigned reserves the right to reject any one or all bids without assigning any reason thereof". It is violation of Balochistan Public Procurement Rules 2014, Rule No. 40. Stated as under;


40. Announcement of evaluation reports.— (1) Procuring Agencies shall announce and upload on Authority's web the results of bid evaluation in the form of a report giving justification for acceptance of lowest evaluated bid, and reasons for non-acceptance of all other bids or rejection of each bid at least ten days prior to the award of procurement contract.

Provided that a copy of the evaluation report shall be provided to any bidder who may request for the same.

The above information is forwarded for the purpose of avoiding the mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
