**Sub:** Violation of Balochistan Public Procurement Rules 2014, Project Director, Rehabilitation of Pasni Fish Harbour, Pasni's Tender Notice for Construction of Breakwater and Repair of Existing Breakwaters at Pasni Fish Harbour.

Dear Sir,

This is with reference to Fisheries Department, Quetta's Tender Notice published in daily "Dawn" on 25<sup>th</sup> August, 2015. It is observed that the advertisement is in violation of the BPPRA Rules 2014.

1. As per advertisement, "no response time for submission of bids is mentioned for the bidders". It is violation of BPPRA Rules 2014, Rule No. 16 (2). Stated as under;

*16. Response Time. — (1) The Procuring Agency shall give due consideration to the scope, magnitude and nature of procurement, while deciding the response time which shall not be less than fifteen (15) calendar days from the date of publication of Notice Inviting Tender in the newspapers or uploading on the website, as the case may be, in case of National Competitive Bidding, and shall not be less than forty five days (45) from the date of publication of Notice Inviting Tender in the newspapers or uploading on the website, in case of International Competitive Bidding*

2. Also it is mentioned that, "the tender documents may be obtained on non-refundable payment of PRs 13,000/-", which appears costly in light of the BPPRA Rules 2014, Rule No. 26(2). Stated as under;

*26. Provision of Bidding Documents. — (2) The Procuring Agency may charge a fee for bidding documents, which shall not exceed the cost of preparation and printing.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- 1- Request for the issuance of Tender Document should be supported with:
  - (a) Full name, permanent address, telephone and fax numbers, email & the organizational structure.
  - (b) Registration Certificate of Pakistan Engineering Council in category C3 and above and for specialization CE03 or /and Ce05.
  - (c) Registration (NTN Certificate) from Income Tax Department including CNIC.
  - (d) Bio-Data of Technical Staff employed and to be made available for working on the project.
  - (e) Details of works executed during the last five years.
  - (f) Turn-over of at least last three years.
  - (g) Affidavit in which the Bidder undertakes that he is not involved in any litigation.
  - (h) Affidavit that the Bidder has not been blacklisted by any Government / semi-Government / Autonomous body.
- 2- The bid money specified would be pledged in the name of Project Director RPFH Project @ 2% of estimated cost, in the shape of bank guarantee or deposit at call from a scheduled bank, otherwise it will not be entertained.
- 3- If the firm / partner is involved in partnership deed, then complete details / instructions and power of attorney will be submitted on affidavit by the proprietor.
- 4- Conditional and telegraphic tenders will not be entertained
- 5- The procuring agency may reject any of or all bids or proposals at any time prior to the acceptance of a bid or proposal, subject to the relevant provisions of BPPRA Rules-2014.
