**Sub: Violation of Balochistan Public Procurement Rules 2014, Additional Director,
Government Medical Store Depot Baluchistan, Quetta's Re-Tender Notices for Purchase of
Medicines and Other Store Items.**

Dear Sir,

This is with reference to Government Medical Store Depot Baluchistan, Quetta's Re-Tender Notices published in daily "Jang" on 30th March, 2017. It is observed that the advertisements are in violation of the Balochistan Public Procurement Rules 2014.

As per advertisement, 15 days of response time is not given and the last date for submission of tender is on 07-04-2017, which is 6 days short. It is violation of BPPRA Rules 2014, Rule No. 16 (1). Stated as under;

***16. Response Time.** — (1) The Procuring Agency shall give due consideration to the scope, magnitude and nature of procurement, while deciding the response time which shall not be less than fifteen (15) calendar days from the date of publication of Notice Inviting Tender in the newspapers or uploading on the website, as the case may be, in case of National Competitive Bidding, and shall not be less than forty five days (45) from the date of publication of Notice Inviting Tender in the newspapers or uploading on the website, in case of International Competitive Bidding.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
