**Sub: Violation of Balochistan Public Procurement Rules 2014, Under Secretary (B & A),
Services and General Administration (S&GAD), Civil Secretariat Baluchistan, Quetta's Re-
Tender Notice for Procurement of Stationary Items.**

Dear Sir,

This is with reference to S&GAD, Quetta's Re-Tender Notice published in daily "Jang" on 29th October, 2016. It is observed that the advertisement is in violation of the Baluchistan Public Procurement Rules 2014.

As per advertisement, 15 days of response time is not given and the date for submission of tender is on 08-11-2016, which is 4 days short. It is violation of BPPRA Rules 2014, Rule No. 16 (1). Stated as under;

16. Response Time. — (1) The Procuring Agency shall give due consideration to the scope, magnitude and nature of procurement, while deciding the response time which shall not be less than fifteen (15) calendar days from the date of publication of Notice Inviting Tender in the newspapers or uploading on the website, as the case may be, in case of National Competitive Bidding, and shall not be less than forty five days (45) from the date of publication of Notice Inviting Tender in the newspapers or uploading on the website, in case of International Competitive Bidding.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
