**Sub:** Violation of Balochistan Public Procurement Rules 2014, Executive Engineer-I, B & R Provincial, District Barkhan's Tender Notice for Rehabilitation of Road.

Dear Sir,

This is with reference to B&R Provincial, District Barkhan's Tender Notice published in daily "Jang" on 1<sup>st</sup> November, 2015. It is observed that the advertisement is in violation of the BPPRA Rules 2014.

As per the advertisement, "the Tender form fee under Sr. No. 1, 2 & 3 is given as PRs 20,000/-, PRs 100,000/- and PRs 75,000/- respectively", which appears costly in light of the Balochistan Public Procurement Rules 2014, Rule No. 26(2). The Rule is quoted below for your reference;

*26. Provision of Bidding Documents. — (2) The Procuring Agency may charge a fee for bidding documents, which shall not exceed the cost of preparation and printing.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
