**Sub:** Violation of Balochistan Public Procurement Rules 2014, Project Director, Uplifting of Chaman Town, C & W Department, Quetta's Pre-Qualification Notice for Construction Work.

Dear Sir,

This is with reference to C & W Department, Quetta's Pre-Qualification Notice published in daily "Jang" on 4<sup>th</sup> September, 2016. It is observed that the advertisement is in violation of the Balochistan Public Procurement Rules 2014.

As per the advertisement, the pre-qualification document fee is charged as PRs 15,000/- in the advertisement, which appears costly in light of the Procurement Rule and is violation of Baluchistan Public Procurement Rules 2014, Rule No. 19(1) (b). The Rule is quoted below for your reference:

*19. Process of Pre-qualification – (1) (b) Procuring Agency shall provide a set of pre-qualification documents containing scope of contract, a clear set of requirements for qualification and evaluation criteria to any supplier or contractor, subject to payment of price, if any, which shall not exceed the limit, as prescribed in these Rules, and shall indicate the time and place where the documents can be obtained. Alternatively, if the Procuring Agency does not wish to issue pre-qualification documents, it shall include the scope of work and a clear set of requirements for pre-qualification and the evaluation criteria in the notice for pre-qualification;*

The above information is forwarded for the purpose of avoiding the mis-procurement charge and with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.
