Dear Sir,

This is with reference to MC, Tasp Punjgur's Tender Notice published in daily "Jang" on 5th April, 2016. It is observed that advertisement is in violation of the BPPRA Rules 2014.

As per advertisement, Chairman, Municipal Committee, Tasp Punjgur reserve the right to reject all or any bids without assigning any reason thereof under the provision of Balochistan Public Procurement Rules 2014. It is violation of BPPRA Rules 2014, Rule No. 38(4). Stated as under;

38. Cancellation of Bidding Process. — (4) The Procuring Agency shall, upon request by any of the bidders, communicate to such bidder, grounds for the cancellation of bidding process, but is not required to justify such grounds.

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
