Sub: Violation of Balochistan Public Procurement Rules 2014, Chairman, Municipal Committee, Turbat's Tender Notice for Purchase & Supply of Miscellaneous Items.

Dear Sir,

This is with reference to MC, Turbat's Tender Notice published in daily "Dawn" on 5<sup>th</sup> March, 2016. It is observed that advertisement is in violation of the BPPRA Rules 2014.

1. As per advertisement, it is mentioned that the tender will be issued on 21-03-16 only. It is violation of BPPRA Rules 2014, Rule No. 16 (2). Stated as under;

*16. Response Time. - (2) Procuring Agency shall ensure that bidding documents are available to the interested bidders from the first day of publication of Notice Inviting Tender in the newspapers or uploading on the website, as the case may be.*

2. Also, Chairman, Municipal Committee, Turbat reserves the right to reject any or all the tender without assigning any reason. It is violation of BPPRA Rules 2014, Rule No. 38(4). Stated as under;

*38. Cancellation of Bidding Process. — (4) The Procuring Agency shall, upon request by any of the bidders, communicate to such bidder, grounds for the cancellation of bidding process, but is not required to justify such grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
