DIRECTOR GENERAL HEALTH SERVICES BALOCHISTAN QUETTA'S
TENDER NOTICE FOR PURCHASE OF MISCELLANEOUS ITEMS.**

This is with reference to your office letter No. TL16 / 01 04 / 3A Dated 1st April, 2016 on the subject cited above. In this regard, it is stated that the tender Notice was send to the DGPR from the office of the Provincial Coordinator EPI, Balochistan Quetta, uploaded on BPRA web site on 26th March 2016 and published on 30th March, 2016 in major National Daily including Daily "DAWN", JANG Quetta, SAHAFAT Quetta and others through Director General Public Relation. The Tender opening date is fixed for 18th April, 2016 thus 18 days are given for issuance of tender Documents in accordance with section 16 "Response Time" of Balochistan Procurement Rules 2014. The tender documents were available for issuance after its publication in newspaper on 30th March 2016. However, due to typing error, in the letter issued to DGPR and the tender uploaded on the BPRA web site, the date for issuance of bidding document was mentioned as 09 instead of 29th March, 2016. However, as mentioned above, the bidding documents were already available in the office and issued on the 30th March, 2016.

In view of foregoing, it is stated that the mistake in date was due to error on part of EPI Balochistan office which is being rectified through a corrigendum. A letter for corrigendum has already been issued to DGPR for correction on 8th April, 2016. (All relevant copies of documents are enclosed).

Sub: Violation of Balochistan Public Procurement Rules 2014, Director General, Health Services Balochistan, Quetta's Tender Notice for Purchase of Miscellaneous Items.

Dear Sir,

This is with reference to Health Services Balochistan, Quetta's Tender Notice published in daily "Jang" on 30th March, 2016. It is observed that the advertisement is in violation of the Balochistan Public Procurement Rules 2014.

As per the advertisement, the tender documents are issued up to 09-03-2016, which is incorrect. However if we assume it to be 09-04-2016 still the documents are issued for 11 days only which means tender documents are not available for 15 days. The rule "Response Time" includes purchase of tender documents for the bidder from the date of publishing of advertisement till the date of submission of bids. It is violation of BPPRA Rules 2014, Rule No. 16 (2). Stated as under;

- ✓ **16. Response Time.** — (1) *The Procuring Agency shall give due consideration to the scope, magnitude and nature of procurement, while deciding the response time which shall not be less than fifteen (15) calendar days from the date of publication of Notice Inviting Tender in the newspapers or uploading on the website, as the case may be, in case of National Competitive Bidding, and shall not be less than forty five days (45) from the date of publication of Notice Inviting Tender in the newspapers or uploading on the website, in case of International Competitive Bidding*

The above information is forwarded for the purpose of avoiding mis-procurement charge and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.


