**Sub: Violation of Punjab Procurement Rules 2014, Medical Superintendent,
Teaching Hospital, Dera Ghazi Khan's Tender Notice for Purchase of Plant/
Machinery, IT/ Network Equipment and Medical Equipment.**

This is with reference Teaching Hospital, Dera Ghazi Khan's Tender Notice, published in daily "Nawaiwaqt" on 31st December, 2018. It is observed that the advertisement is in violation of the Violation of PPRA 2014.

As per advertisement, "Quantity of above mentioned items may be increased or decreased according to the requirement", whereas per rules, any change in tender conditions, specifications and quantity after the opening of the bid by procuring agency is not allowed under Rules. However according to PPRA 2014, Rule No. 59 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

59. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works:
(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:
(iv) repeat orders not exceeding fifteen per cent of the original procurement;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Interested eligible bidders may get the bidding documents from procurement section of this Hospital on submission of written application along with payment of non-refundable fee of Rs.1000/- (One Thousand only), as per schedule given below only during working hours. A copy of bidding documents/requirements is also available for information on the website of PPRA and D.G.Khan Medical website.

- Single stage-two envelopes bidding procedure (A) Technical bid (B) Financial bid with clearly written, name of bidder and type of bid shall be applied. The bidder shall furnish, call deposit in the name of Medical Superintendent, Teaching Hospital D.G.Khan. (Refundable) in Pak rupees, without the offer shall be ignored.

- 02% Bid Security (estimated price) shall be attached with the bid in the shape of CDR from any scheduled bank otherwise tender will be rejected.

- Sealed bids are required to be brought in person by the authorized representative of the interested bidder on 15-01-2019 at 11:00 am and will be opened on the same day at 12:00 noon in the presence of the bidders or their authorized representatives. Late bids will be rejected.

- The bidders are required to give their lowest and final price, since, as far as possible: there will be no negotiations on the prices.

- A pre-bid meeting will be held in committee room of this Hospital on 29th December 2018 at 10:00 am. All the interested bidders are requested to submit their reservations, if any, in writing by which will be discussed in the meeting for appropriate decision

- PPRA Rules 2014(amended 2016) will be followed.

- In case the date of opening or last date of sale of tender documents is declared as a public holiday by the Government or non-working day due to any reason, the next official working day shall be deemed to be the date of sale, submission and opening of tenders accordingly. The time and venue shall remain the same.
