**Sub: Violation of Punjab Procurement Rules 2014, Deputy Director (P&D),
Water and Sanitation Agency (WASA), Faisalabad's Tender Notice for Services.**

This is with reference to WASA, Faisalabad's Tender Notice, published in daily "Dunya" on 2nd November, 2018. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per the advertisement, the tender fee for work is given as PRs 10,000/-, which appears costly in light of the Procurement Rule and is violation of Punjab Procurement Rules 2014, Rule 25(7). Stated as under;

25. Bidding documents.- (7) The procuring agency shall, on payment of such fee as the procuring agency may determine keeping in view the cost of printing and provision of the documents, provide a set of bidding documents to the prospective bidders.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

TERMS & CONDITIONS

1. Tender documents can be obtained from the office of Deputy Director (P&D), WASA immediately i.e. date of uploading on PPRA website up to 05-11-2018 during working hours on depositing requisite tender fee in WASA Account.
2. Sealed tenders will be received and opened in the presence of Deputy Director (P&D) and Committee, in Committee Room, WASA Main Office Jail Road Faisalabad on 06-12-2018. Bids receiving time is 12:00 P.M. & Opening time is 12:30 P.M.
3. Authorized representative of the contracting firms can purchase/receive tender documents on provision of original authority letter.
4. Earnest money must be accomplished with the tender which should be valid for at least Sixty (60) calendar days after the date specified for opening of the bids otherwise it will not be entertained.
5. Tenders shall be opened in the presence of interested bidders or their representatives who may care to be present.
6. Procedure of open competitive bidding = Single Stage two Envelope System.
7. The bidders shall submit the bid in two parts. The first part shall be for specification, called the "Technical Bid", the second one for the cost, called the "Financial Bid". These bids should be sealed and submitted in two separate envelopes.
8. The technical bid will be opened first and evaluated. If the specification of bid meet the requirement of bid documents, then bid will be qualified for opening Financial Bid, otherwise the same shall be returned unopened.
9. The bidder shall include all taxes and duties in the bid price.
10. The whole process of bidding shall be governed by the PPRA Rules.
11. All the bidding documents shall be uploaded on the PPRA website as well as WASA website.
12. No Judicial proceedings could be initiated against decision of the committee and the decision of the committee shall be final.
13. A Pre-Bid meeting will be held on 14/11/2018 at 12:00 hours in Committee Room of WASA Head Office, Jail Road, Faisalabad.
14. All payment shall be made in Pakistani currency (PKR).
