Sub: Violation of Punjab Procurement Rules 2014, DIG Police Operation Officer, DIG Operation Office, Lahore's Tender Notice for Purchase of Miscellaneous Items.

Dear Sir,

This is with reference to DIG Operation Office, Lahore's Tender Notice, published in daily "Dawn" on 3rd August, 2018. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per advertisement, "a decrease in the purchase of tender items can be made", whereas per rules, any change in tender conditions, specifications and quantity after the opening of the bid by procuring agency is not allowed under Rules. However, according to PPRA 2014, Rule No. 59 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

59. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works:

(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:

(iv) repeat orders not exceeding fifteen per cent of the original procurement;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

TERMS AND CONDITIONS OF TENDER

1. The tenderers must read and understand all the terms and conditions earlier, so that there exists a conformity between the required store and samples.
2. Tenders must be sealed having the names of the required items written in bold letters.
3. The tenderers shall provide all items to the DIG Operations Office Lahore at his own expense immediately after the approval of tender.
4. There must be a separate tender with sample for each item and the rates of items must be written in figures as well as words
5. Sealed offer complete in every respect must be supported with pay order, bank guarantee of 03% of total estimated cost in favor of DIG Operations Office Lahore.
6. In case of breach of tender, earnest money or any its part can be forfeited.
7. A decrease in the purchase of tender items can be made. The approved rate shall stand valid by 30-06-2019.
8. The participating contractor must be govt. approved. Income Tax and Sales Tax No. registration certificates copies must be attested.
9. The district purchase committee shall first recommend for the purchase of tendered item. And the undersigned shall be competent to accept or not accept the recommendation of purchase committee.
10. Undersigned shall be authorized to reject all tenders under PPRA Rules.
11. Performance guarantee security is five percent.
