# CORRIGENDUM

With reference to the Tender Notice inviting Proposals for procurement of CCTV Cameras on rental basis for installation at Sensitive polling stations in District Toba Tek Singh during General Election 2018, published in daily Express dated 30-06-2018 under IPL No 6870, following changes are made:

1. As directed by the Home Department, the number of Sensitive Polling Stations has been reduced from 319 to 232.
2. Clause-09 of the Tender Notice may be read as "The office of the Deputy Commissioner/procuring agency can reduce or increase the quantity of any item under provisions of PPRA Rules as per need".
