Sub: Violation of Punjab Procurement Rules 2014, Executive Engineer, Khushab Canal Division, Khushab's Tender Notice for Procurement of Reserve Stock of Stone.

This is with reference to Khushab Canal Division, Khushab's Tender Notice, published in daily "Jang" on 3rd May, 2019. It is observed that the advertisement is in violation of PPRA Rules 2014.

As per terms and condition No. 15 in the advertisement, "the quantity of work can be increased/ decreased as per site requirement", whereas per rules, any change in tender conditions, specifications and quantity after the opening of the bid by procuring agency is not allowed under Rules. However according to PPRA 2014, Rule No. 59 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

- **59.** Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works:
- (c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:
- (iv) repeat orders not exceeding fifteen per cent of the original procurement;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- 4. Earnest money of @ 2% of estimated amount in shape of deposit call payable to Executive Engineer, Khushab Canal Division Khushab, issued by Scheduled Bank of Pakistan must be attached with the tenders. No tender document will be accepted without earnest money.
- Contract documents, drawings and estimate of the work etc can be seen in the office of the undersigned on any working day during office hours.
- Tender forms will be issued from this office within office hours immediately after the publication of the invitation to the bid up to 17.05.2019.
- 7. The tenders will be received in the office of under signed on 18.05.2019 up to 11:30 Hours and opened by the Tender Opening Committee on the same day at 12:00 Hours sharp in the presence of contractors or their authorized representatives who may dare to attend.
- No conditional or their authorized representative who may dare to attend.
- 9. Any of the total bids can be rejected on the basis of evaluation criteria through:-
- a. The procuring agency may reject all bids of proposals at any time prior to the acceptance of a bid proposal.
- b. The procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.
- The payment will be made only on receipt of funds specified for the work, against accepted work done or provision existing in the technical sanctioned estimate,

whichever is less.

- 11. In Case total tendered amount is less than 5% of approved estimated (DNIT) amount, the lowest bidder will have to deposit additional performance security from any scheduled bank under clause 26 A of contract agreement within 15-days of issuance of notice and in consideration of Government of Punjab Finance Department Notification No. RO (Tech) FD 1-2/83 VI(P) dated: 24.01.2006.
- Deposit calls of 2nd and 3nd lowest bidders will be released after approval of Tenders by competent authority.
- If two or more contractors / firms become the lowest by quoting the same rates for any item, the decision of authority competent to accept the tender for award of contract will be final.
- 14. The Acceptance letters to the successful bidders will be issued as per funds available with the Division and after fulfillment all codal formalities.
- The quantity of work can be increased / decreased as per site requirement.
