Sub: Violation of Punjab Procurement Rules 2014, Medical Superintendent, Government Mian Mir Hospital, Lahore's Tender Notice for Purchase of Various Items.

This is with reference to Government Mian Mir Hospital, Lahore's Tender Notice, published in daily "The News" on 7th Sep, 2018. It is observed that the advertisement is in violation of the Violation of PPRA 2014.

As per advertisement, the Procuring Agency, however, may reject all bids or proposals at any time prior to the acceptance of a bid or proposal without assigning any reason. However, it is not complying with, PPRA 2014 Rule No. 35, which requires that reason should be communicated to bidders. Therefore the advertisement is in violation of Rule No. 35 of PPRA Rules 2014. Stated as under;

*35. Rejection of Bids :- (1) the procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.
(2) the procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

2. Interested bidders may get the bidding documents immediately after the date of publication & detailed specifications of items from the Accounts Department, Government Mian Meer Hospital, Lahore during working hours from 08.00 A.M. to 02.00 P.M. on any working day on submission of written request along with a copy of CNIC & on payment of non-refundable fee of Rs.1,000.00. However, a copy of the Bidding Documents is also available for information only on the website of Punjab Procurement Regulatory Authority (<https://ppra.punjab.gov.pk>).

3. 2% Bid Security should be attached with the Financial Bid in the shape of Bank Draft, Pay Order or Call Deposit Receipt from any scheduled bank in the name of the Medical Superintendent, Government Mian Meer Hospital, Lahore, otherwise the Offer / Bid shall be rejected.

4. Single Stage - Two Envelop Bidding Procedure will be applied. The envelop shall be marked as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" separately in bold and legible letters. Financial Proposal of Offer / Bid found technically non-responsive shall be returned un-opened to the respective bidders.

5. All the procurements shall be governed under the Punjab Procurement Rules, 2014 and amended.

6. Sealed bids are required to be brought and dropped in person by the authorized representative of the interested bidders up to 12.00 P.M. on 24.09.2018 positively which will be opened on the same day at 12.30 P.M. in the presence of the available Bidders or their authorized representatives by the Purchase Committee of this Hospital in the Conference Room of Government Mian Meer Hospital, Lahore.

7. The bidders are required to submit the company profiles including Technical, Engineering, Managerial capabilities, after-sales services and past experience/ performance along with their technical bids.

8. All documents should contain proper page marking, attached in sequence as indicated for evaluation in the bidding document duly signed and stamped by the authorized person. Moreover, signing and stamping of each page of bidding document / form is mandatory otherwise bid shall be rejected straightaway.

9. The Procuring Agency, however, may reject all bids or proposals at any time prior to the acceptance of a bid or proposal without assigning any reason.

10. All prices must include relevant taxes and duties, where applicable. If there is no mention of taxes, the offered / quoted price shall be considered as inclusive of all prevailing taxes / duties.

11. Interested bidders shall provide samples of all quoted items on or before the opening of tenders positively.

12. In case of holiday, tenders will be opened on next working day.
