**Sub: Violation of Punjab Procurement Rules 2014, Executive Engineer, 5<sup>th</sup> Building Division, Lahore's Pre-Qualification Notice for Supply/ Installation of Escalators.**

Dear Sir,

This is with reference to 5th Building Division, Lahore's Pre-Qualification Notice, published in daily "Express" on 6<sup>th</sup> July, 2018. It is observed that the advertisement is in violation of the Punjab Procurement Rules 2014.

As per advertisement, 5th Building Division, Lahore has restricted the bidders for the original of company/ manufacturer to be of USA/ Europe/ Japan origin only and has not added "**or equivalent**" with it, which is not allowed under PPRA 2014, Rule No. 10(2). Stated as under:

*10. Specifications:- (2) The Specifications shall be generic and shall not include references to brand names, model numbers, catalogue numbers or similar classifications but if the procuring agency is satisfied that the use of, or a reference to, a brand name or a catalogue number is essential to complete an otherwise incomplete specification, such use or reference shall be qualified with the words "or equivalent".*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.

- Any further particulars, the firms wish to furnish.

The prequalification applications shall be evaluated on the basis of PPRA's Rules Government of Punjab criteria for prequalification. The other related information required in this regard should also be provided.

Any further information / details in this connection may be had from the Executive Engineer 5<sup>th</sup> Building Division, Lahore on any working day. Only pre-qualified firms will be invited to participate in tendering. The competent authority reserves the right to accept / reject the prequalification as per PPRA Rules.
