Sub: Violation of Punjab Procurement Rules 2014, PSP, District Police Officer, D. G. Khan's Tender Notice for Purchase of Miscellaneous Items and for Works.

Dear Sir,

This is with reference to Office of DPO, D. G. Khan's Tender Notice, published in daily "Jang" on 6th July, 2018. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per advertisement, "The quantity of the items may be increased/ decreased as per availability of fund", whereas per rules, any change in tender conditions, specifications and quantity after the opening of the bid by procuring agency is not allowed under Rules. However according to PPR 2014, Rule No. 59 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

59. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works:

(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:

(iv) repeat orders not exceeding fifteen per cent of the original procurement;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

3. **TERMS & Conditions:**

1. Bid shall comprise a single sealed package containing two separate envelopes.
- 1) **TECHNICAL PROPOSAL** (Detail of all items onlie firms letter head pad along with bidding documents, earnest money.
 - 2) **FINANCIAL PROPOSAL** (Rate of all items including all Taxes charges, whatever as per following for the firms letter head pad.

The envelope should be marked in bold letter as "Technical Proposal" and "Financial Proposal".

2. Technical Proposal on 23.07.2018 at 10:00 hours while Financial Proposal shall remain (in sealed forms) in the custody of undersigned and would be opened after receipt of the Technical report, in the presence of qualified bidders. The Technically qualified lowest bid would be accepted. The Financial proposal of bids found Technically un-acceptable shall be returned un-opened to the respective bidders.
3. The bidders have to bring their samples of items at the time of opening of Tenders otherwise the offer shall be ignored.
4. The bidders shall submit earnest money @ 3% of total value of the contract with their Financial proposals in the shape of pay orders/Bank Draft of any schedule Bank in favour of the District Police Officer DG Khan. In case of non acceptance of Tenders the earnest money will be refunded after finalized of Tenders.
5. In case of acceptance of Tenders the bidders shall deposit a security @ 5% the total value of contract in the form of call deposit, in the name of the District Police Officer DG Khan and draw the contract agreement. Security shall be refunded on successful completion of the contract.
6. The quantity of the items may be increased / decreased as per availability of fund.
7. The department reserves the right to accept or reject all Tenders without assigning any reason.
8. All the Rates which were quoted in Tenders are for the Financial Year 2018-19 (From 01.07.2018 to 30.06.2019).
9. Any of the Total Bids can only be rejected on the basis of evaluation criteria:
 - 1) The procuring agency that rejects all bids of proposal at any time prior to acceptance of a bid or proposal.
 - 2) The procuring agency shall upon request communicate to any bidders the ground for its rejection of all bids are proposal but shall not be required to justify those grounds.
