Sub: Violation of Punjab Procurement Rules 2014, Municipal Officer (Infrastructure), Municipal Corporation, Bahawalpur's Pre-qualification Notice for Construction/Shifting Works.

Dear Sir,

This is with reference to Municipal Corporation, Bahawalpur's Pre-qualification Notice, published in daily "The News" on 9th April, 2018. It is observed that the advertisement is in violation of the Punjab Procurement Rules 2014.

As per the advertisement, 15 days of response time is not given and the last date for submission of application is on 19-04-2018, which is 4 days short. It is violation of Punjab Procurement Rules 2014, Rule No.14 (1). Stated as under;

14. Response time:- (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the Pre-qualification Notice under the prescribed procedures or issue a corrigendum and extend date accordingly.

QUALIFICATION CRITERIA AS PER PPRA GUIDELINES.

1. Name of Firms/Contractors partnership deed articles of association in case of company/limited firm, complete address and telephone Number of persons with power of attorney in favour of person authorized by the firm contractor.
2. Attested copies of enlistment/renewal for the year 2017-18 with LG&CD Department in category "A" and or higher (Rs. 273.761 Million and above) and registration of Pakistan Engineering Council in specialized category C03 (Slaughter House Construction and general Civil Engineering Works/Projects) for the financial year 2017-18.
3. (i) Year of establishment of Firms/Company with proof.
(ii) Number of similar nature of works, cost of each work (equal or greater amount) Scope of work with verification from concerned Executive Engineer.
(iii) Name of similar projects already completed during last three years with completion certificate from the concerned officer and number of projects presently in hand along with their magnitude and period of completion and about quality and space of work from the client department.
4. Proof of financial standing duly supported with documentary proof/Bank Certificate (Balance sheet duly certified the concerned ban officer be provided.)
5. Proof of registration with the income Tax Department and registered with Punjab Revenue Authority along with a certificate of payment of taxes for the last 3 years.
6. Particulars of specified construction equipment/machinery available with the firm/contractor with verified ownership documents, specially mention equipment the applicants intends to deploy to the work/works Applicant should also include the yearly increase in T&P in the last three year.
7. List of equipment with its number/mark/model/condition and location along with proof of its ownership.
8. (i) Permanent business management, financial management and technical staff.
(ii) List of Graduate Engineer, Sub Engineer, Surveyors and Draftsman on the Pay Roll (with proof) along with their experience and standing with the company/firm and appointment letter, proof of payment of salary of technical clerical staff.
9. (i) The applicant must establish its financial soundness and a certificate from Chartered Accounts firm. Copy of up to date balance sheet should also be part of the application.
(ii) Bank certificate and bank statement clearly indicating financial strength of the firms/contractors for last 3 years.
(iii) Bank documents to establish financial buoy capacity & proof of Credit line if any.
10. Details of any Arbitration/litigation or similar proceedings against any Government or semi Government Department, showing extent and result
11. Undertaking on judicial paper Rs. 100/- that the firm was never black listed by any Government or semi Government organization.

RULES AND REGULATIONS

1. The contractor not pre-qualified will be communicated the reason for non prequalification of the firm.
2. Any concealment about the information details mentioned above will result into disqualification of the firm/contractor.
3. In case of incomplete information pre-qualification/application will be rejected and will not be considered for pre-qualification.
4. The late receipt of applications after due date and time mentioned above will not be entertained at all.
5. No court proceeding against the pre-qualification committee will be allowed and the decision of the committee will be final.
6. Applicant firm/contractors are required to give under-taking that they have carefully studied the pre-qualification notice and will abide by the rules and regulation.

Note:

Contractor should have at least 8-10 year experience in this field and have constructed at least 1-2 modern slaughter house.

Supervisory Staff (Work Supervisor / Computer Operator / Helper) on work charge basis are required to supervise the execution of above works. Application of candidates will be received in the office of the undersigned up to 19-04-2018.

Pre-Qualification Performa will be issued at cost of Rs. 10000/- Non-Refundable up to 15-04-2018. Documents fee and for documents which will be issued by the Head Clerk which are to be filled in and submitted along with other documents before the last date of submission of documents for Pre-qualification.

If, on said date no contractor will submit documents the next date to submit the documents will be 28-04-2018 and this date will be the opening date also.

These documents preformed should be filled in and signed by the original contractor and not be any authorized persons.
