**Sub: Violation of Punjab Procurement Rules 2014, Deputy Commissioner, Office  
of Deputy Commissioner, Nankana Sahib's Expression of Interest Notice for  
Establishment of Tent City for Birthday Celebrations.**

This is with reference to DC, Nankana Sahib's EOI Notice published in daily "Nawaiwaqt" on 7<sup>th</sup> July, 2019. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per advertisement, "The District Administration reserves the right to accept or reject the EOI of any firm without assigning any reason". However, it is not complying with, PPRA 2014 Rule No. 35, which requires that reason should be communicated to bidders. Therefore the advertisement is in violation of Rule No. 35 of PPRA Rules 2014. Stated as under;

- 35. Rejection of Bids :-** (1) *the procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.*  
(2) *the procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the EOI under the prescribed procedures or issue a corrigendum and extend date accordingly.

The District Administration intends to engage the services of reputed Event Management Companies for the administration & establishment of said Tent City. The Tent City approximately for One Lac (1,00,000) persons would be established and the land will be provided by the Government. The TORs are as follow:-

I)	Each Block for twenty five hundred (2500) persons would be established.
II)	Block wise quotation will be required and time to time order would be placed on the basis of arrival of people/ requirement.
III)	Fire Proof / Water proof tent-age would be provided.
IV)	Carpet would be laid in each tent.
V)	Temporary fence for each block would be established along-with razor wire.
VI)	Each block would be fully facilitated with following facilities but not limited to:- <ul style="list-style-type: none"> <li>➤ Security Posts/ Watch Tower</li> <li>➤ Portable toilets.(Separate for males and females)</li> <li>➤ Provision of hot water in showers/ toilets</li> <li>➤ Site construction &amp; maintenance</li> <li>➤ Layout plan</li> <li>➤ Proper lane</li> <li>➤ Potable/ Clean Drinking Water Points/ Posts</li> <li>➤ Electricity (temporary connection by LESCO/ Generator backup)</li> <li>➤ Garbage collection points / disposal at allocated sites</li> <li>➤ Fencing</li> <li>➤ Departure clean up.</li> <li>➤ Floor bedding – including mattress/ pillows/ Duvet/ Sheets</li> <li>➤ Common Kitchen for each block</li> </ul>
VII)	Each tent would be established for ten (10) persons. (Separate for male and female)
VIII)	Emergency alert system would also be installed in each block.
IX)	Four (04) No. entry points and Four (04) No. exit points for each block would be established.
X)	Public safety Walk Through Gates at the entry / exit point of each block would be provided.
XI)	Fire extinguishers points would be established in each block.
XII)	Point for establishment of dispensary and parking of ambulances / fire bridge vehicles would be established in each block.
XIII)	Parking area for each block would be established separately.
XIV)	No smoking signs would be displayed.
XV)	The electric system shall be accessible to the general public and shall be in accordance with the electric safety code.
XVI)	Adequate and safe heating system
XVII)	The District Administration reserves right to change any TOR as per requirement on the spot.

You are requested to submit Expression of Interest (EOI) along with non-refundable processing fee amounting to Rs. 5,000/- in the form of a Bank Draft / Pay Order / Banker's Cheque in favour of Commissioner, Lahore Division, Lahore. The last date for the submission of EOI is **24<sup>th</sup> July, 2019 by 03:00 P.M** in office of the Commissioner, Lahore Division, Lahore with following mandatory documents:-
