This is with reference to PMDFC, Lahore's Tender Notice, published in daily "Newsworld" on 7th Dec 2018. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per advertisement, 15 days of response time is not given and the last date for the submission opening of tenders is given as 18-12-2018, which is 3 days short. It is a violation of PPA 2014, Rule No 14(1) stated as under:

14. Response time.- (1) The procuring agency shall decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice keeping in view the complexity of the procurement, availability and urgency but in no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding any procurement charge under the PRA, and with request to re-invite the tender under the prescribed procedure or issue a corrigendum and extend the tendering.
