Subject: Violation of Punjab Procurement Rules 2014. Assistant Secretary (General)/DDO, Board of Revenue, Punjab, Lahore's Tender Notice for Purchase of Stationery & Computer Stationery Articles.

This is in reference to your office's letter No.TL17/0908/1A dated 9th August, 2017 regarding the subject cited as above.

2. In this context it is stated that according to Rule 12 of the Punjab Procurement Rules 2014, "procurement over one hundred thousand rupees (one lac) and up to the limit of two millions (20 lac) rupees shall be advertised on PPRA's website in the manner and format specified by regulation by the PPRA from time to time. **These procurement opportunities may also be advertised in print media, if deemed necessary by the procuring agency.**"

3. The advertisement was uploaded on the website of PPRA on 02.08.2017 (copy enclosed). The MD PPRA was also informed, vide letter No.4866-2017/1424 dated 02.08.2017. The request, for publication of advertisement was made vide No.4866-2017/1423-Admn/SC, dated 01.08.2017, to the Director General, Government of the Punjab, Public Relation Department, Lahore for the advertisement of the Tender Notice in the newspapers Urdu 'Daily Nawa-i-Waqt' (copy enclosed) and English 'Daily The News' (copy enclosed) were published. The advertisement was published in the daily "Nawa-i-Waqt" on 04.08.2017 whereas the advertisement was published in the daily "The News" on 05.08.2017 but the same has been indicated to be published on 07.08.2017, in the letter of Transparency International-Pakistan dated 09.08.2017.

4. It is stated that advertisement in Urdu Newspaper was published well in time in accordance with PPRA Rules, Punjab, and there was a delay of publication of advertisement in the daily "The News", only one day, which is not attributable to this office, since the Tender Notice was sent to the Director General, Government of the Punjab, Public Relation Department, Lahore on 01.08.2017 and the advertisement in the daily "Nawa-i-Waqt" was published on 04.08.2017. No procurement has so far been done and all codal formalities shall be fulfilled.

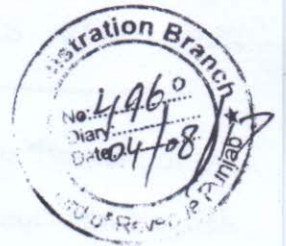
