Dear Sir,

Transparency International Pakistan has received a complaint against Tender for Furniture and Fixture Items for the Various Departments. The complaint (annexure) is enclosed for your ready reference.

The complainant has alleged that the closing and opening date for the subject tender in the advertisement published in daily Dawn Karachi and Jang Multan was 05-12-2018 while said tender uploaded on the Punjab Procurement Regulatory Authority website, the dates for the submission and opening is given as 06-12-2018.

TIP's observation is that it is a violation of Punjab Procurement Rules 2014.

Vice Chancellor, BZU is requested to kindly examine the complaint, and if found genuine direct the concerned department to re-invite the tender as per Punjab Procurement Rules 2014 and take necessary action against all those officers involved in corrupt practices.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.
