**Sub: Violation of Punjab Procurement Rules 2014, Executive Engineer, Kalabagh
Headwork's Division, Daudkhel's Tender Notice for Restoration of Guide Wall.**

Dear Sir,

This is with reference to Kalabagh Headwork's Division, Daudkhel's Tender Notice, published in daily "Nawaiwaqt" on 8th May, 2018. It is observed that the advertisement is in violation of the Punjab Procurement Rules 2014.

As per the advertisement, "the procuring agency dare the right to increase/decrease the quantum of work as per site requirement", whereas per rules, any change in tender conditions, specifications and quantity after the opening of the bid by procuring agency is not allowed under Rules. However according to PPRA 2014, Rule No. 59 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

59. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works:

(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:

(iv) repeat orders not exceeding fifteen per cent of the original procurement;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Sealed tenders are invited under PPRA Rules 2014 on item rates basis against Market Rates System District Mianwali (Bi Annual 1st January 2018 to June 2018) from the approved Contractors of Irrigation Department who have got their names enlisted /renewed in the appropriate category for the year 2017-18 and deposited their enlistment/renewal fee with the Department under the following terms & conditions:-

1. The blank tender form/contract documents can be obtained from the office of the Executive Engineer, Kalabagh Headworks Division, Daudkhel District Mianwali upto 24-05-2018 during office hours. No tender form will be issued after this date. No tender form except those issued by the Revenue Clerk office of the Executive Engineer, Kalabagh Headworks Division, Daudkhel will be accepted.
2. The Contractors who desire to obtain tender form shall have to submit an application on his printed letter pad alongwith following original documents and their attested copies.
 - a. Enlistment/renewal letter for financial year 2017-18 with Irrigation Department.
 - b. Registration Certificate issued by Pakistan Engineering Council for the year 2017-18.
 - c. Copy of CNIC
 - d. Receipt of professional Tax for the year 2017-18
 - e. Receipt of enlistment/renewal fee 2017-18
 - f. Managing partnership deed of firm alongwith registered power of attorney authorized with agent if he appears on behalf of Company/Firm.
3. The bidders will be required to furnish bid Security (call deposit) 5% of estimated cost from any scheduled bank of Pakistan and should be attached with the bidding documents/tender, failing which the tenders will not be entertained.
4. Contract documents, drawings and estimate of the work etc can be seen in the office of the undersigned on any working day.
5. Tender forms will be issued by Revenue Clerk of Kalabagh Headworks Division Daudkhel within office hours immediately after the publication of the invitation to the bid up to 24-05-2018 (office hours).
6. The tenders will be received in the office of under signed on 25-05-2018 at 1400 Hours and opened by the Tender Opening Committee on the same day at 1430 Hours sharp in the presence of contractors or their authorized representatives who may care to attend.
7. No conditional / doubtful, received by dak or any other means tenders will be accepted.
8. The procuring agency may reject all bids of proposals at any time prior to the acceptance of a bid or proposal. The procuring agency dare the right to increase/decrease the quantum of work as per site requirements.
9. The payment will be made on actual work done basis after clearance by the Third Party Monitoring Consultants/ Checking Committee etc. if any.
10. In case total tendered amount is less than 8% of approved estimated amount, the lowest bidder will have to deposit additional performance security from any scheduled bank under clause 28 A of contract agreement within 07-days of issuance of notice, otherwise deposit call shall be forfeited.
NOTE: And further clarified by the Finance Department vide Notification No.RO(Tech)FD-1-2/83, VI(P) dated 24-01-2006 that if contractor quote rates 11 % below the technically sanctioned estimate and then the corresponding additional performance security @ 11% for subsequently (%age below the estimated cost) shall be deposited.
11. The acceptance letter to the successful bidders will be issued as per funds available with the Division.
12. If any of the above clauses contradict the PPRA Rules, the PPRA Rules will prevail.
