Sub: Violation of Punjab Procurement Rules 2014, Director Administration, Parks and Horticulture Authority, Lahore's Expression of Interest Notice for Enlistment of Pharmacy

Dear Sir,

This is with reference to Parks and Horticulture Authority, Lahore's Expression of Interest Notice published in daily "Nai Baat" on 9th August, 2016. It is observed that the advertisements are in violation of the Punjab Procurement Rules 2014.

As per advertisement, no expression of interest document for consultancy is issued for bidders, whereas as per Rule No. (47), it is mandatory to provide a set of EOI document that should include evaluation criteria for the applicants. Stated as under;

47. Expression of interest.- (1) A request for expression of interest shall be advertised in accordance with the provisions of rule 12 and rule 13.

(2) The expression of interest shall contain the following information:

(a) the name and address of procuring agency;

(b) an appropriate description of the assignment providing scope of the intellectual and professional services required;

(c) closing date and place of the submission of the expression of interest;

(d) criteria for short listing or prequalification where required; and

(e) any other information that the procuring agency may deem appropriate to disseminate at this stage.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the EOI notice under the prescribed procedures or issue a corrigendum and extend date accordingly.

EXPRESSION OF INTEREST FOR ENLISTMENT OF PHARMACY

The Parks and Horticulture Authority intends to hire the services pharmacist / druggists / Chemists for enlistment on PHA panel. The pharmacist / druggists / Chemists having adequate experience in relevant field and fulfilling eligibility criteria are encouraged to apply for enlistment.

1. The proposals should be addressed to the Director Administration, PHA, Lahore.
2. The pharmacist / druggists / Chemists must be licensed and registered from the concerned Board / Council.
3. The pharmacist / druggists / Chemists shall provide the required medicine.
4. The pharmacist / druggists / Chemists must have minimum 03(three) No of branches in Lahore.
5. The pharmacist / druggists / Chemists shall provide its NTS & GST certificate.
6. Pharmacist / Druggists / Chemists must have sound financial back ground and should have the financial statement of at least three previous years.
7. The pharmacist / druggists / Chemists should not have practical experience of less than 10 years.
8. The pharmacist / druggists / Chemists providing any additional facility to PHA employees shall be preferred.
9. Pharmacist / Druggists / Chemists interested can submit their profile along with their proposals and required documents in sealed envelopes (duplicate) in person or through registered mail on the addressed given below on or before **22 August 2016** at 01.00 pm.
10. Any concealment of facts shall be considered reason enough to disqualification.
11. The decision of Authority as per approved criteria shall be final and no relaxation shall be given against such decision on any forum.
12. Any proposal received against the above detailed criteria shall be rejected.
