Sub: Violation of Punjab Procurement Rules 2014, Chairman/ Chief Officer, Municipal Committee, Kabirwala's Quotation Notice for Purchase and Supply of Miscellaneous Items.

Dear Sir,

This is with reference to Municipal Committee, Kabirwala's Quotation Notice published in daily "Express" on 9th December, 2017. It is observed that the advertisement is in violation of the PPRA 2014.

As per advertisement, "The authority has the right to change the quantity (increase or decrease) of bids, one or all the quotations, without assigning any reason before approval of bid rate", whereas per rules, any change in tender conditions, specifications and quantity after the opening of the bid by procuring agency is not allowed under Rules. However according to PPRA 2014, Rule No. 59 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

59. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works:


(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:

(iv) repeat orders not exceeding fifteen per cent of the original procurement;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.

QUOTATION NOTICE

Municipal Committee Kabirwala wants to purchase of Motor Cycle Rickshaw Trolley for Solid Waste Transportation, Supply of Plants and supply of Hand Carts for Solid waste collection from the manufactures dealers registered with G.S.T & income tax department having following qualification.

1. The contractor/suppliers have a large experience of manufacturing and having a work order of such supplying to any procurement agency at least one number.
2. Should be registered with General sales tax and Income tax department for the year 2016-17.
3. Should have the sound experience of manufacturing & supplying of the same nature machinery to different organization.
4. Financial out lay of current year should be provided and be sound.
5. Managerial organogram with document.

The Suppliers / contractors fulfilling the above eligibility criteria will submit their quotation along with CDR of Bid Security as required, in the office of MC Kabirwala as mentioned against each item as listed below:-

1. Single stage two envelopes bidding procedure will be used for the procurement of above said items as per PPRA Rule 2014 under section 38.
2. The Quotations will be received from the date of exhibition on Website of PPRA in the office of MC Kabirwala up to before opening of bids.
3. The bids will be submitted with CDR of Bid Security as required from any schedule bank in favour of MC Kabirwala of its quoted rates and should be received up to 29.12.2017 at 12:00 PM.
4. The Quotation /bids received will be opened by the Purchase Committee upto 29.12.2017 at 12:30PM on the same day in the office in the presence of bidders (available) or their authorized representatives.
5. The authority has a right to reject/change the quantities, of bids, one or all quotations without assigning any reason before approval of bid rate.
6. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.
7. The procuring agency shall upon request communicate to any bidder, the ground for its rejection of all bids or proposal, but shall not be required to justify those grounds
8. Bid rates should be filled in figure as well as in words.
9. No rebate on bid rate and no conditional bid well are acceptable.
10. The bid validity time will be 20 days, will start from date of opening of bids.
