Sub: Violation of Punjab Procurement Rules 2014, Manager Procurement and Contracts, Cattle Market Management Company, Sargodha Division's Pre-Qualification Notice for Different Types of Goods and Rendering Services.

This is with reference Cattle Market Management Company, Sargodha Division's Pre-qualification Notice, published in daily "Jang" on 9th February, 2019. It is observed that the advertisement is in violation of PPRA 2014.

As per advertisement, 15 days of response time is not given and the last date for the submission/ opening of bids is given as 18-02-2019, which is 5 days short. It is a violation of PPRA 2014, Rule No.14 (1). Stated as under;

14. Response time:- (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.
