Sub: Violation of Punjab Procurement Rules 2014, District Livestock Officer, District Livestock Department, Muzzafargarh's Tender Notice for Purchase of Computer with Printer, Refrigerator and Furniture.

Dear Sir,

This is with reference to District Livestock Department, Muzzafargarh's Tender Notice, published in daily "Dawn" on 11th May, 2016. It is observed that the advertisement is in violation of the Punjab Procurement Rules 2014.

1. As per advertisement, "the competent authority reserves the right to reject any or all of the tenders without assigning any reason thereof." It is not complying with Rule No. 35 of PPRA 2014, which requires that reason should be communicated to bidders. Stated as under;

35. Rejection of Bids :- (1) the procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.

(2) the procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.

2. Also, "Quantity of items may be increased/ decreased according to availability of budget". Any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However according to PPRA 2014, Rule No.59 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

59. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works:

(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:

(iv) repeat orders not exceeding fifteen per cent of the original procurement;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

2. As per PPRA Rules, 2014 (Rule 38 (2) (a) single stage-two-envelopes bidding procedure, both tender (Technical + Financial) should be submitted in separate envelopes marked as Technical Proposal and Financial Proposal.
3. All bids must be accompanied by a Bid Security amounting to Rs. 65000/- (2% of Bid Price) in the form of CDR, in the name of the undersigned.
4. As per Govt. rules, Income Tax/ Withholding Tax and GST will be responsibility of the bidder and the rates will be valid up 30.06.2016.
5. Successful bidder shall be bound to provide performance guaranty in the shape of scheduled bank guarantee equivalent to 10% of the contract value in the name of the undersigned along with an Affidavit/ Rate Contract on Judicial Paper valuing Rs. 100/- to the effect that firm will not claim increase in the quoted rates and will be responsible for quoting exorbitant rate from any other purchasing organization in the country during this financial year.
