3	The procuring agency may require the bidders to furnish a bid security not exceeding five percent of the estimated price. Explanation; - In this rule, the words "estimated price" mean the price of procurement estimated by the procuring agency before initiation of the process of procurement.	27
4	Any of the total bids can only be rejected on the basis of evaluation criteria. Though, (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal (2) The procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.	35
