Sub: Violation of Punjab Procurement Rules 2014, Director of Education (Colleges), Education Department, Sargodha Division's Tender Notice for Provision of Items.

Dear Sir,

This is with reference to Education Department, Sargodha Division's Tender Notice published in daily "The News" on 12th December, 2017. It is observed that the advertisement is in violation of the PPRA 2014.

As per the advertisement, the Purchase Committee has right to reject all the tenders without assigning any reason. However, it is not complying with, PPRA 2014 Rule No. 35, which requires that reason should be communicated to bidders. Therefore the advertisement is in violation of Rule No. 35 of PPRA Rules 2014. Stated as under;

35. Rejection of Bids :- (1) *the procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.*
(2) *the procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.

The Tenders will be received till 30-12-2017 at 11:30 A.M. through registered mail or courier services and on the same day at 12:00 P.M. Technical bids will open in the presence of bidders or their authorized representatives. And after the evaluation of technical bids, the financial bids will be opened on the given date & time of the technically qualified firms. The tender form/documents can be received from the office during office hours after the publishing in newspaper till 29-12-2017. The details of items are available in tender documents.

Terms & Conditions:

- The whole purchase process will be executed in accordance with the Punjab Procurement Rules, 2014.
- Original call deposit receipt equal to 5% percent of total estimated price of each object (Refundable) in the name of the undersigned issued by any scheduled bank of Pakistan is must be attached with technical bid. Cheques will not be acceptable.
- Tender must be completed in all respect. Tender must be according to specification only and rates must be filled in the proper column of the tender form issued by the office and every page of tender must signed and stamped by owner of the firm
- Single stage - two envelopes procedure in accordance with Punjab Procurement 2014 Rules 38 (2) (a) will be adopted. The envelopes shall be marked as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" in bold and legible letters to avoid confusion. There will be no change acceptable in the model, brand, and manufacturer etc which is required in the tender documents. Over writing/cutting will not be admissible.
- Tender Forms can be obtained from this office on payment of Rs.500/- per tender (non-refundable) during office hours.
- Separate Tender Form for each object & College will be accepted. Furthermore the successful bidder is bound to submit 25% as stamp Paper Duty & 10% as performance security before the issuance of the supply order, which will be forfeited in case of any deficiency or failure in provision of the items/supply in the stipulated time period mentioned in the supply order.
- The articles mentioned in the supply order will be handed over to the concerned Principal at the premises of his/her college in stipulated time period according to specification. The concerned committee will check the supply Physically & Technically and after the inspection, the committee will issue the physical & Technical verification and completion certificate in the favor of the firm after that the payment will be made to the concerned firm.
- Quoted rates shall be valid up to 30 June 2018. Quoted Rates will be for brand new items and without taxes. All the taxes will be applied according to Govt. Rules which will be payable by the firm.
- The Purchase Committee before awarding the supply order may seek clarifications and samples of quoted items from bidding organization (if needed).
- The successful bidders will be bound to supply the articles within given time after issuing the supply order. In case of failure, according to the clauses/terms & conditions of the tender fine will be imposed on the concerned firm and action will be initiated according to Punjab Procurement Rules 2014.
- The Purchase Committee has right to reject all the tenders without assigning any reason. After the acceptance of terms & conditions of the tender by the firm, the firm has no right to violate any terms & conditions. In case of violation, action will be taken against the concerned firm according to concerned rules of Punjab Procurement Rules 2014.
- Bids which will be incomplete, without sign & stamp, unsealed, without bid security and late by specified time shall not be considered. Bidders are requested to carefully read and comply instructions/requirements mentioned in the bidding documents before submitting their bid, after that no query will be entertained.
