Sub: Violation of Punjab Procurement Rules 2014, Assistant Engineer, Local Government & Community Development Department, Rajanpur's Tender Notice for Construction of Boundary Wall of Graveyard.

This is with reference to (LG&CD) Department, Rajanpur's Tender Notice, published in daily "Nawaiwaqt" on 12th February, 2019. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per the advertisement, the tender fee is charged as PRs 2, 00, 000/-, which appears costly in light of the Procurement Rule and is violation of Punjab Procurement Rules 2014, Rule 25(7). Stated as under;

25. Bidding documents.- (7) The procuring agency shall, on payment of such fee as the procuring agency may determine keeping in view the cost of printing and provision of the documents, provide a set of bidding documents to the prospective bidders.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

The Local Govt. & Community Development Department District Rajanpur has invited tenders for the approved development scheme @ 2nd Bi-Annual 2018 1st July 2018 to 31st Dec, 2018 (percentage of below & above on estimated cost) from the registered contractors who have deposited registration/ renewal fee for the year 2018-19 in LG&CD, Department District Rajanpur on the following terms and conditions:-

1. Tender documents are available in the office of the Assistant Engineer, Civil Sub Division, LG&CD, Rajanpur, soon after date of publication of the invitation to bid (PPRA Punjab Rule, 25(1) on written application accompanied with attested photocopy of enlistment letter, identity card of contractor, power of attorney of the owner of firm.
2. Tender fee will be received in shape of amount deposited in bank by Challan 32-A under the head of 1300-Misc. Receipt 1390 Other Receipt.
3. Tender fee will be received according to the notification issued by the Superintending Engineer, LG&CD Punjab Lahore vide his No. SE/LG&CD/4 (59)/2013 dated 31.08.2015.
4. Tender will not be issued to those contractors whose performance of work remained unsatisfactory during the previous year or failed to complete the previous work.
5. Tender will be issued from the office of the Assistant Engineer, Civil Sub Division, LG&CD, Rajanpur up to **25-2-19** till 3:00 P.M. on written application attached with **earnest money equal to 5% of estimated cost of bid** in the form of CDR from any scheduled bank.
6. Tender Form will be received on **27-2-19** at **2:00 P.M.** and will be opened at the same date at **2:30 P.M.** at office of the **Assistant Engineer, LG&CD, Civil-Sub-Division Rajanpur** in the presence of Tender Opening Committee and contractors or their representatives.
7. Conditional tenders / over writing / blank tender will not be entertained.
8. The Department will not responsible for supply of any machinery or material.
9. Any one or all of the bid can be rejected on the basis of evaluation criteria through procuring agency on any ground.
10. Estimated cost and other information are available in the office of the undersigned which can be seen during office hours with the head clerk.
11. The work will be executed as per provision in the T.S. estimate.
12. The lowest bidders whose bid will be lesser than 5% of the T.S Estimated Cost, shall have to deposit the difference amount between the estimated cost and rate quoted by the bidder as performance security in form of CDR within 15-days after the approval of rates, which will be returned to contractor on successful completion of work as per rules otherwise work will be cancelled and earnest money would be forfeited as per law without any further notice.
13. The contractor would be eligible for issuance of tender who have valid PEC Certificate for the year 2018.
14. The procuring agency may reject all bid, or proposals at any time prior to the acceptance of a bid or proposal.
15. The procuring agency should, upon request, communicate to any bidder the ground for its rejection of all bids or proposals but shall not be required to justify those grounds.
16. The work orders will be issued when the funds will be received from the Government.
