**Sub: Violation of Punjab Procurement Rules 2014, Superintendent, Central Jail Department,
Multan's Tender Notice for Purchase of Miscellaneous Items.**

Dear Sir,

This is with reference to Central Jail Department, Multan's Tender Notice, published in daily "Dawn" on 12th June, 2018. It is observed that the advertisement is in violation of the Punjab PRA 2014.

1. As per advertisement, Central Jail Department, Multan will reserve the right to cancel the tender partially or totally without showing any reason. However, it is not complying with, PPRA 2014 Rule No. 35, which requires that reason should be communicated to bidders. Therefore the advertisement is in violation of Rule No. 35 of PPRA Rules 2014. Stated as under;

35. Rejection of Bids :- (1) the procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.

(2) the procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.

2. Also, "the quantity of articles may increase or decrease as per demand of factory of this jail", whereas per rules, any change in tender conditions, specifications and quantity after the opening of the bid by procuring agency is not allowed under Rules. However according to PPRA 2014, Rule No. 59 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

59. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works:

(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:

(iv) repeat orders not exceeding fifteen per cent of the original procurement;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- 1 All the contractors shall insert the sealed Quotations in Tender box on 30.06.2018 at 11:00 AM which shall be opened by the purchase committee at 11:30 AM on the same day in the presence of contractors, in case the opening of tender is delayed due to any reason, the next date shall be announced on the spot for which no further advertisement shall be made in this regard.
- 2 The sealed envelop shall bear legible name and address of the firm.
- 3 The tender form may be obtained from Central Jail Multan @ Rs. 500/- per form (not refundable) during office hours till one day prior to the date of tender. The receipt of purchase of tender shall be attached with Tender form.
- 4 In case of non approval of tender for the year 2019-2020, the department shall continue the present tender till 30.09.2019.
- 5 In case of fake call deposit the proceeding under section Pakistan penal code shall be initiated.
- 6 The damaged or over written tender shall be rejected.
- 7 The tender holder shall not put forth any provision.
- 8 The call deposit or surety deposit of first and second bidder shall not be released until the approval of the Inspector General of Prisons, Punjab, Lahore is received. Moreover the undersigned shall have the authority to cancel the tender partially or totally without showing any reason.
- 9 Tender which do not fulfill the above provisions shall be rejected and the contractors should have not right to go any court of law.
