Sub: Violation of Punjab Procurement Rules 2014, Project Director, University of Gujrat, Hafiz Hayat Campus, Gujrat's Tender Notice for Establishment Works.

Dear Sir,

This is with reference to University of Gujrat, Hafiz Hayat Campus, Gujrat's Tender Notice, published in daily "The News" on 11th November, 2016. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per advertisement, "University of Gujrat reserves the right to cancel reject one or all proposals without assigning any reason and re-advertise the same at any stage". It is not complying with Rule No. 35 of PPRA 2014, which requires that reason should be communicated to bidders. Stated as under;

35. Rejection of Bids :- (1) *the procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.*
(2) *the procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

University of Gujrat (UOG) invites sealed tenders/bids on the basis of Single Stage Two Envelopes (Technical and Financial) according to PPRA Rules 2014 from the construction companies / firms (i) having valid registration with Pakistan Engineering Council (PEC) (ii) Enlisted with UOG for FY 2016-17 and (iii) who have undertaken or completed similar projects costing Rs 01.00 billion or more in last five(05) years, i.e., 2011 and onward for the scheme “Establishment of University of Gujrat Sub-Campus at Narowal” with following terms & conditions

1. Technical Proposal will be submitted with following document

- i. A affidavit on legal stamp paper that the firm/ individual is not defaulter / blacklisted and have not indulged in litigation with any Government/Semi Govt. Department or Authority Autonomous Body
- ii. Certificate of registration with Pakistan Engineering Council (Valid) with proprietorship, address and engineers working with the company
- iii. Latest/valid copy of Enlistment with University of Gujrat for the year 2016 -17. The tenders/bids without enlistment shall not be entertained/ considered
- iv. Copies of enlistment(valid) with other Government departments, institutions
- v. Annual Audit report for last three years 2013-2015
- vi. Certificate from Income Tax Department and Professional Tax Certificate of last three years
- vii. In case of joint venture, the lead partner shall have to fulfill the basic eligibility criteria and other partner shall have a valid registration at-least in C-3 category including original “Joint Venture Agreement” on stamp paper
- viii. List of similar projects costing Rs 01.00 billion or more completed within last five (05) years clearly mentioned projects costs of executed works with copies of work orders and completion certificates
- ix. List of similar projects costing Rs 01.00 billion or more in hand by the firm with documentary evidence.
- x. CVs, PEC registration certificate and affidavit on stamp paper in original of employed staff is mandatory for submission, and
- xi. Undertaking on stamp paper (in original) of ownership of tools and plants is mandatory for submission.

2. Bidding documents for the submission of financial proposals/bids will be obtained immediately after publishing of this notice from Project Engineer, Office Room No. 109 Vice Chancellor's Secretariat, UOG on written request accompanied with attested copies of valid PEC license, identity card of contractor / managing partner/ director of the firm along with registered power of attorney on payment of prescribed tender fee in the Account No. 09-000-7 at Bank of Punjab UOG Branch CBr Code 0165. However, the tender/bidding documents are also available immediately after publishing of this notice on university website, i.e., www.uog.edu.pk and PPRA Punjab website, i.e., www.ppra.punjab.gov.pk for convenience and guidance.

3. Sealed tenders/bids will be received before 1:00 AM of November 27th, 2016 and will be opened 12:00 noon in Committee Room, Vice Chancellor's Secretariat, UOG in front of Works Committee, UOG

4. Tendered rates and amounts should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender bid documents.

5. Conditional tenders and tenders not accompanied with earnest money to 2% of estimated cost in shape of CBR Bank Draft / Cashier's Cheque of any scheduled Bank in favor of Treasurer UOG, attested copies of registered partnership deed and power of attorney (in case of firms) will not be entertained

6. Incomplete and inappropriate tenders will not be entertained by Works Committee UOG.

7. In case of joint venture, the major partner must fulfill the basic criteria, otherwise the proposal regarding joint venture will not be accepted

8. Works Committee, University of Gujrat reserves the right to reject one or all proposals without assigning any reason and re-advertise the same at any stage
