Sub: Violation of Punjab Procurement Rules 2014, Medical Superintendent, Government Teaching Hospital Shahdara, Lahore's Tender Notice for Purchase of Miscellaneous Items.

Dear Sir,

This is with reference to Government Teaching Hospital Shahdara, Lahore's Tender Notice, published in daily "Express" on 14th December, 2016. It is observed that the advertisement is in violation of the Punjab Procurement Rules 2014.


In the advertisement, the tender receiving date is given as 29-12-2016, while the tender opening (technical proposals) is kept on 2-01-2017. It is violation of PPRA 2014, Rule 30(1). Stated as under;

***30. Opening of bids.**– (1) The date for opening of bids and the last date for the submission of bids shall be the same; and, bids shall be opened at the time specified in the bidding documents which shall not less than thirty minutes after the closing time for the submission of bids.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the notice under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.

For Sr#1, Availability of the drugs quoted on at least one Retail pharmacy chain of any company operating at least five pharmacies in different parts of Lahore under the same name and bill warranty will be provided by the firm for testification of 3 year supply. Other terms & conditions are mentioned in the tender enquiry remain same.
2. For Sr#2, only firms having Gelate Certified Raw Material may participate.
3. Interested eligible bidders may get the bidding documents containing terms & conditions and detailed specification form the Purchase Section Govt. Teaching Hospital Shahdara Lahore on the submission of written application on payment of Rs. 1000/- (non-refundable) as tender fee during working hours.
4. Single Stage- Two Envelopes bidding procedure shall be applied. The envelopes shall be marked as financial proposal and technical proposal in block and legible letter. Financial proposal of the bids found technical non-responsive will be returned unopened to the respective bidders.
5. Sealed bids are required to be brought in person by the authorized representative of the interested bidders on the proposed date and to be dropped in the tender box by the closing time. The late arrivals and bids send by post will not be entertained. The tenders (Technical Proposals) will be open by the purchase committee in presence of the bidders or their authorized agents (if available) in the conference room of Govt. Teaching Hospital Shahdara Lahore.
6. The Earnest Money @ 0.2% of quoted estimated price in shape of Call Deposit in favor of Medical Superintendent Govt. Teaching Hospital Shahdara Lahore should be attached with the tender documents (Photocopy (with hidden amount) with Technical Offer and original with Financial Offer).
7. Procurement shall be governed under the Punjab Procurement Rules 2014. Tender Notice may be seen on PPRA website. (www.ppra.punjab.gov.pk).
8. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any concerned bidder the grounds for its rejection of bids or proposals but is not require to justify those grounds.
