Sub: Violation of Punjab Procurement Rules 2014, Chairperson Health Council, Tehsil Headquarters Hospital, Taunsa Sharif's Tender Notice for Purchase of Machinery/ Equipment, Furniture, Computer with Accessories, Photocopier Machine and HD CCTV Cameras with DVR Installation and Repair of Machinery Equipment, Generators and Ambulances of Health Council.

Dear Sir,

This is with reference to Tehsil Headquarters Hospital, Taunsa Sharif's Tender Notice, published in daily "Dawn" on 13th January, 2017. It is observed that the advertisement is in violation of the PPRA Rules 2014.


As per advertisement, "Purchase/ Repair Committee reserve the right to reject/ cancel any or all tenders without assigning any reason thereof". However, it is not complying with, PPRA 2014 Rule No. 35, which requires that reason should be communicated to bidders. Therefore the advertisement is in violation of Rule No. 35 of PPRA Rules 2014. Stated as under:

35. Rejection of Bids :- (1) the procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.
(2) the procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

TERMS & CONDITIONS

The following documents must be attached with the Technical Bid. Otherwise, tender shall not be acceptable.

1. Tenderers append an attested photocopy of computerized national identity card issued by Nadra with the tender.
2. Income Tax/Sales Tax/Professional Tax Clearance certificate for the year 2015-16.
3. Firm submit an affidavit on a stamp paper of Rs.100/- denomination to the effect that neither is the firm blacklisted nor the rates given in the tender are higher than any other district's.
4. Rates offered in the tender must be inclusive of all prevalent taxes. No excuse shall be acceptable afterwards.
5. Incomplete tenders or the ones received after stipulated date / time shall not be acceptable.
6. Rates quoted in the tender must be on F.O.R basis, which shall remain enforced by 30-06-2017. And tenderers shall be bound to make supply on the given rates.
7. The deduction of Income Tax/Sales Tax shall be made at the time of payment of bill as per rules.
8. Complete description of guarantee / warranty / availability of spare parts of all equipments be submitted.
9. Purchase/Repair Committee reserves the right to reject/cancel any or all tenders without assigning any reason thereof. The decision of Purchase/Repair Committee shall be final.
10. Attach the receipt of purchased tender with the tender.
11. Receipt of tender firm must be typed on printed pad, signed and enclosed in an envelope. Rates offered in the tender must also be written in words besides figures.
12. Tenders bearing cutting or overwriting shall not be acceptable.
13. All rates must be according to the specification given in the tender. The specification given otherwise shall not be acceptable.

SPECIAL INSTRUCTIONS

1. Attach tender security with the Technical Proposal. Otherwise, tender shall not be acceptable.
2. Under the PPRRA Rule No. 36(b), Technical Offers and Financial Offers be sent in separate envelopes and Technical Bids/Financial Bids must also be written in bold letters on them. Both these sealed envelopes must be enclosed in a large sealed envelope.
3. An identity card issued by Nadra as well as an application addressed to Chairperson, Health Council Tehsil Headquarters Hospital, Taunsa Sharif on the letter head pad must be submitted at the time of purchasing tender.
