Sub: Violation of Punjab Procurement Rules 2014, Deputy Managing Director (Engg), Water and Sanitation Agency (WASA), LDA, Lahore's Tender Notice for Hiring of Services of Private Security Agencies.

This is with reference WASA, LDA, Lahore's Tender Notice, published in daily "Jang" on 11th Oct. 2018. It is observed that the advertisement is in violation of the Violation of PPRA 2014.

As per the Terms and Conditions No. 9, "the procuring agency may increase and decrease the number of staff and properties to be secured given in bidding documents as per requirement", whereas per rules, any change in tender conditions, specifications and quantity after the opening of the bid by procuring agency is not allowed under Rules. However according to PPRA 2014, Rule No. 59 (c) (iv), repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

59. Alternative methods of procurements.- A procuring agency may utilize the following alternative methods of procurement of goods, services and works:

(c) direct contracting: a procuring agency shall only engage in direct contracting if any of the following conditions exist:

(iv) repeat orders not exceeding fifteen per cent of the original procurement;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Rs.200 (Pak Rupees Two Hundred Only)
3. Single stage two envelope bidding procedure will be adopted. Bids (Technical & Financial) prepared in accordance with the instructions given in the Bidding Documents must be accompanied by a Bid Security 500,000/- (Rupees Five Hundred Thousand Only) in the shape of CDR in favour of Director (P&S) WASA which is within 5% of estimated cost. Last date for purchase of bidding documents is 24-10-2018. The Bids (Technical & Financial) must be delivered at the address given above on 26-10-2018 at 12:00 P.M. The Technical bids will be opened on the same day and the same venue at 12:30 P.M. in presence of the bidder's / bidders representatives who choose to participate.
4. Only technically responsive bidders will be qualified for opening of financial bids. Financial bids found technically non responsive shall be returned unopened to the bidders.
5. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under Punjab PPRA Rules 2014 (Rule-35)
6. Conditional tender will not be accepted.
7. No tender via telegraph or by post will be accepted.
8. Tendered rates and amount should be filled in figures as well as in words and tenders should be signed as per general directions given in the tender documents.
9. Procuring agency may increase or decrease the number of staff and properties to be secured given in bidding documents as per requirement.
10. Pre-bid meeting will be held on 20-10-2018 at 12:00 P.M.
11. The bid will be valid for the 120-days.
