**Sub:** Violation of Punjab Procurement Rules 2014, District Officer Sports, Sports Complex Liaquat Bagh, Rawalpindi's Tender Notice for Provision of Sports Uniform, Track Suits, Shoes, Socks and Sports Equipment etc. for Games.

Dear Sir,

This is with reference to Sports Complex Liaquat Bagh, Rawalpindi's Tender Notice, published in daily "Dunya" on 11<sup>th</sup> September, 2016. It is observed that the advertisement is in violation of the PPRA Rules 2014.

As per advertisement, the tender submission date is given as 25-09-16, while tender opening date is given as 26-09-16. Therefore the advertisement is in a violation of PPRA Rules 2014, Rule 30(1). Stated as under;

*30. Opening of bids.— (1) The date for opening of bids and the last date for the submission of bids shall be the same; and, bids shall be opened at the time specified in the bidding documents which shall not less than thirty minutes after the closing time for the submission of bids.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
