Subject: - **MIS-PROCUREMENT IN NEWSPAPER ADVERTISEMENT.**

**Memorandum:-**

Kindly refer to your office letter No. L&M(PPRA) 3-29/2018-4357 dated 10.07.2018, regarding the subject cited above.

2. It is intimated that this office initiated the process of procurement on 02.07.2018 vide this office Memo No. 34429 dated 02.07.2018 (copy enclosed as **Annexure-“A”**) and sent Tender Notice to the Director, Public Relations, Bahawalpur for its publishing in the newspapers. The same Tender Notice was also sent to the Deputy Commissioner, Bahawalnagar vide this office letter No. 34831 dated 03.07.2018 (copy enclosed as **Annexure-“B”**) for publishing / uploading on the PPRA website. Accordingly, the Tender Notice of this district was uploaded on PPRA website on 04.07.2018. A copy of the screen shot of PPRA website mentioning Tender Notice under reference is enclosed as **Annexure-“C”**.

3. The Tender Notice under reference was published in the daily Nawa-e-Waqat Multan on 09.07.2018 and daily Nation, Lahore on 11.07.2018. Copies enclosed as **Annexures-“D”, “D-1” & “D-2”**, respectively.

4. It is further mentioned that due to delay in office of the Director, Public Relations, Bahawalpur, the Tender Notice could not be published in the newspapers well in time. However, it stands published on PPRA website since 04.07.2018 whereas tender opening date is 20.07.2018.


5. It is also worth mentioning that General Elections are due on 25.07.2018 while all the deployment will be in place on 23.07.2018. In this situation, the items

mentioned in the Tender Notice are required to be available by the said date i.e. 23.07.2018.

In such circumstances, this office will not be able to extend the time frame further keeping in view exigency of the time limit.

6. In view of the above, it is requested that the date of uploading Tender Notice on PPRA website i.e. 04.07.2018 may kindly be considered as starting date for calculation of the response period. However, this office will ensure adherence to all rules and transparency measures relating to the procurement process, please.
