**Sub: Violation of Punjab Procurement Rules 2014, Major for Director General, Pakistan Rangers (Punjab), Lahore's Tender Notice for the Provision of Animal Ration per Day.**

Dear Sir

This is with reference to Pakistan Rangers (Punjab), Lahore's Tender Notice, published in daily "The Nation" on 14<sup>th</sup> May, 2016. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per advertisement, "Director General, Pakistan Rangers (Punjab), reserves the right to accept or reject any or all the tenders without assigning any reason." It is not complying with Rule No. 35 of PPRA 2014, which requires that reason should be communicated to bidders. Stated as under;

**35. Rejection of Bids :-** (1) *the procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.*  
(2) *the procuring agency shall upon request communicate to any bidder, the grounds for its rejection of all bids or proposals, but shall not be required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.

**NOTE:**

- Every firm will have to submit the price of per animal daily diet as per above scale and price of per item/Kg (for all the items) separately and every firm will have to submit tender quotation for all sectors.
- Tender forms along with detailed directions/conditions of provision of Ration against payment of Rs. 3000/- may be had from Ordnance Branch Headquarters Pakistan Rangers (Punjab), Ghazi Road Lahore Cantt up to 30th May, 2016.
- Firms registered with Pakistan Rangers (Punjab) will submit 2% and unregistered will submit 5% earnest money in shape of Pay Order/ Bank Draft in favour of Director General Pakistan Rangers (Punjab), along with the form.
- All the firms will quote Registration No. of General Sales Tax and National Tax Number in their tender quotation, otherwise quotation will be rejected. All firms will enter quotation rates including sales tax and other prevailing taxes etc. All firms will themselves pay the Laboratory Test Fee of their samples.
- It is mandatory for each firm to bring every item's marked 30 Kg sample along with its tender form.
- Tenders will have to be dropped in the tender box placed in Headquarters Pakistan Rangers (Punjab) Lahore up to 31st May, 2016 till 11:00 a.m., Which will be opened the same day at 12:00 noon in the presence of bidders.
- Director General Pakistan Rangers (Punjab) reserves the right to accept or reject any or all the tenders without assigning any reason.
