Sub: Violation of Punjab Procurement Rules 2014, University Engineer, Bahauddin Zakariya University, Multan's Tender Notice for Provision of Brick Soiling for Newly Constructed Residences.

Dear Sir,

This is with reference to BZU, Multan's Tender Notice published in daily "Nawaiwaqt" on 12th October, 2016. It is observed that the advertisement is in violation of the Punjab Procurement Rules 2014.

As per the advertisement, the tender fee for work is given as PRs 10,000/-, which appears costly in light of the Procurement Rule and is violation of Punjab Procurement Rules 2014, Rule 25(7). Stated as under;

25. Bidding documents.- (7) The procuring agency shall, on payment of such fee as the procuring agency may determine keeping in view the cost of printing and provision of the documents, provide a set of bidding documents to the prospective bidders.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the notice under the prescribed procedures or issue a corrigendum and extend date accordingly.

2. Every contractor will have to deposit the required Earnest Money (Bid Security) as specified below in shape of Call Deposit/ Draft drawn in favour of University Engineer, Bahauddin Zakariya University, Multan, with Habib Bank Ltd., New Campus Branch or any Scheduled Bank. (No conditional/ telegraphic tenders or by post will be entertained).
3. All tenders can be rejected according to PPRA Rule.
4. Tender documents can be obtained from the office of the undersigned after publication during office hours on payment of the prescribed tender fee, which is not refundable.
5. The tenders from a firm or company should be accompanied by Power of Attorney on judicial paper (if applicable).
6. The contractors involved in any litigation and blacklisted/ de-listed/ debarred from any Government Department and Pakistan Engineering Council are not eligible to participate in tenders.
7. Tenders for each work will be issued to contractors only on written request, whose performance for such works in University is satisfactory and on production of their original documents.
8. Tender rate/ amount should be filled in figures as well as in words and must be signed by the proprietor/ managing partner/ attorney holder in accordance with the general guidance for tenderers.
9. In case of tender amount being less than 5% of the Estimated Cost of the lowest bidder, the contractor/ firm shall have to deposit performance security bond in shape of Bank Guarantee.
10. No tender will be issued to any contractor on the date of receiving of tenders.
