MISCELLANEOUS ITEMS FOR RAMZAN BAZAAR.**

With reference to your letter No. TL19/0305/6A dated 03.05.2019,  
on the subject noted above.

It is pertinent to mention here that District Administration Attock  
has forwarded the advertisement well in-time vide letter No.  
295/DC/ADC(F&P)/Atk dated 18.04.2019 to Director General Public Relation  
Punjab Lahore and accordingly the advertisement was published in DAILY  
DUNYA ISLAMABAD on 23.04.2019. As per PPRA Rules, the same was also  
uploaded on PPRA web Page on 23.04.2019. The response time was given  
15-days i.e 07.05.2019, therefore, no violation of PPRA rules occurs on the part  
of District Administration Attock.

Furthermore, the said advertisement was also published in Daily  
The News on 27.04.2019 for which objection was raised that 15-days of response  
time was not given. It is pointed out that in clause (9) of the said advertisement  
Notice it was mentioned as under:-

"Establishment of Ramzan Bazar is an emergent nature of work. As per PPRA  
rules 2014 chapter III u/s 14 (2), the publication time for quotation is fixed for  
10 days"

This is with reference to Office of Deputy Commissioner, Attock's Tender Notice published in daily "The News" on 27<sup>th</sup> April, 2019. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per advertisement, 15 days of response time is not given and the last date for submission/ opening of tenders is on 07-05-2019, which is 4 days short. It is a violation of PPRA 2014, Rule No.14 (1). Stated as under;

**14. Response time:-** (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

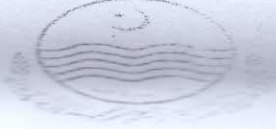
