**Sub: Violation of Punjab Procurement Rules 2014, Medical Superintendent, Lady Aitchison Hospital, Lahore's Tender Notice for Pre-Qualification for Purchase of Pharmacies and Medical Stores for the Local Purchase of Medicines and other Services Contract.**

Dear Sir,

This is with reference to Lady Aitchison Hospital, Lahore's Tender Notice for Pre-Qualification published in daily "Dawn" on 15<sup>th</sup> October, 2017. It is observed that the advertisement is in violation of the PPRA Rules, 2014.

As per the advertisement, 15 days of response time is not given and the last date for submission/opening of bids is on 26-10-2017, which is 3 days short. It is violation of Punjab Procurement Rules 2014, Rule No.14 (1). Stated as under;

*14. Response time:- (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender for pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.

Sealed tenders are invited from the interested, experienced, financially sound pharmacies and medical stores located within a radius of 10 to 12kms off hospital for their prequalification for local purchase of medicines, and the relevant companies & contractors for the annual contract of following other services and machinery, X-ray films and electric wire for Government Lady Aitchison Hospital, Lahore the fiscal year 2017-18.

- All tenders shall be received under PPRA revised Rules 2014 (amended up to 06-01-2016).
- The detail of tender can also be seen on the website of PPRA ([www.ppra.punjab.gov.pk](http://www.ppra.punjab.gov.pk))
- Tender forms along with detail of terms and conditions can be purchased from the hospital cashier on payment of non-refundable fee given against tender from the date of publication till 26-10-2017 (Thursday) during working hours.
- Tender form complete in every respect must be enclosed in one envelope containing Technical & Financial Quotations in two separate sealed envelopes having Technical, Financial, firm's name and nature of tender written in bold letters over them.
- Tenders along with detail and terms and conditions shall be received in the MS Office till 11:00am of 26-10-2017 (Thursday) and the Technical Tenders shall be opened the same day in the MS Office in the presence of tenderers or their authorized representatives at 12:00 noon.
- After the approval of Technical Committee, Financial Tenders shall be opened in the presence of tenderers or their authorized representatives. Tenderers or their authorized representatives shall be duly informed once the decision on its date of opening is made. Moreover, the firm whose Technical Tender is rejected by Committee, its Financial Bid shall be returned to it without being opened.
- A two percent bid security of estimated price in the favor of Medical Superintendent, Lady Aitchison Hospital, Lahore must be submitted with the Financial Bid in an envelope accompanying the tender. Its call deposit No. and date as well as the name of bank must be mentioned in the Technical Bid as proof.
- Tenderers must be registered with Sales Tax, Income Tax and Professional Tax Departments of Government of Pakistan. Attaching copies of Sales Tax, Income Tax and Professional Tax certificates is a must.
- Do attach a copy of valid registration certificate issued by the relevant organizations of Government of Pakistan or Government of the Punjab with the Technical Tender.
- Only Technical Tenders are required from the interested pharmacies and medical stores situated within a radius of 10 to 12 kms off hospital for prequalification for local purchase of multinational, national, imported medicines and disposable surgical items. The purchase of multinational, national, imported medicines and disposable surgical items shall be made from the prequalifying pharmacies and medical stores during the year 2017-18 on local purchase basis. Pharmacies and medical stores must be licensed by Government of the Punjab.
- The specific rules and regulation applied on certain items by Government of Pakistan or Government of the Punjab must be completely complied with.
- Otherwise, bid after declaring non-responsive shall be rejected.
- The decision of MS/Purchase Committee shall be final that they reject all tenders under PPRA Rules 2014 (amended up to 06-01-2016)
