Sub: Violation of Punjab Procurement Rules 2014, Medical Superintendent, Cairns  
Hospital, Pakistan Railways, Lahore's Tender Notice for Supply of Medicines,  
Laboratory Items & Surgical Items.

Dear Sir,

This is with reference to Cairns Hospital, Pakistan Railways, Lahore's Tender Notice, published in daily "The Nation" on 16<sup>th</sup> December, 2016. It is observed that the advertisement is in violation of the Punjab Procurement Rules 2014.

As per advertisement, 15 days of response time is not given and the last date for submission of tender is on 26-12-2016, which is 4 days short. It is a violation of PPRA Rules 2004, Rule No.13 (1). Stated as under;

*13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

### TERMS & CONDITIONS

1. Fresh attested copy of Medical Store's License must be attached with the quotation.
2. Contract will be awarded to a Firm / Medical Store which is financially sound, has good reputation, offers better discounts and Store must be located within 10 Kilometers from the Hospital.
3. Medical Store should be on Ground Floor.
4. Medical Store should be available on prominent place.
5. A Bank Statement for the Financial Year 2015-16 should be attached with the quotation which indicates that a transaction of Rs. 10,00,000/- has been done in the Bank Account of owner of Medical Store.
6. A copy of Income Tax Return for the year 2015-16.
7. The quotation should be accompanied by a Bank Guarantee to the tune of Rs. 1,20,000/- and the amount will remain with the competent authority as security.
8. Medicines will have to be supplied daily as and when required basis.
9. Supply of sub-standard medicines or at higher cost as compared to the market will not be acceptable.
10. The contractor will be bound to supply the medicines as per demand / requirement and any refusal in this context will lead to the forfeiture of the security in favour of the Government.
11. Contractors / Firms and their relatives blacklisted by Pakistan Railways and other Government Departments will not be eligible.
12. The successful contractor will ensure supply of required medicines along with the bill to the undersigned by **1300 hours** sharp on the same day.
