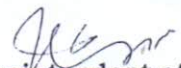

TENDER DOCUMENTS AND TERMS & CONDITION.

1. Police Training Institute, Multan invites sealed bids for the procurement of Stationery/Printing, Misc.Store Items, and Training Aid items, Medicine, Repair of Transport/Machinery & Furniture etc. from well-reputed firms having previous experience and registered with the GST /PST and Income Tax Department. The bid should be addressed to the **Senior Superintendent of Police, Police Training Institute, Multan.**
2. All tender must submit their bids' **Single Stage 'Two Envelope Procedure'** as per Punjab Procurement Rules 2014, as under:-
 - i. The bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the financial proposal and the technical proposal.
 - ii. The envelopes shall be marked as '**FINANCIAL PROPOSAL**' and '**TECHNICAL PROPOSAL**' in bold and legible letters to avoid confusion.
 - iii. Initially, only the envelope marked '**TECHNICAL PROPOSAL**' shall be opened.
 - iv. The envelope marked as '**FINANCIAL PROPOSAL**' shall be retained in the custody of the **procuring agency without being opened.**
 - v. The procuring agency shall evaluate the technical proposal in a manner prescribed in advance without reference to the price and reject any proposal, which does not conform to the specified requirements.
 - vi. During the technical evaluation no amendment in the technical proposal shall be permitted.
 - vii. The financial proposals of bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance.
 - viii. After the evaluation and approval of the technical proposal the procuring agency shall at a time within the bid validity period, open the financial proposals of the technically accepted bids only. The financial proposal of bids found technically non-responsive shall be returned to the respective bidders.
 - ix. The bid found to be the lowest evaluated bid shall be accepted.
3. The purchaser reserves the rights to purchase full or part of above item or reject all bids or proposals in line with Rule 35 of PPRA Rule,2014. The purchaser can also increase/decrease, the quantity of all articles as per requirement.
4. The successful Tender shall deposit, 3% as bid security in the form of deposit at call in favour of the Senior Superintendent of Police, Police Training Institute, Multan within the period specified in advance acceptance of Tender and draw the contract. Security shall be refunded on successful completion of the contract.
5. The successful bidder have to deposited the 02% Performance Guarantee in shape of Bank draft in favour Senior Superintendent of Police, Police Training Institute, Multan in line with rule 56 of PPRA Rules,2014.
6. Any erasing/cutting/crossing and overwriting is not acceptable.
7. An affidavit should be provided by the Tenderer that their firm has never been blacklisted by any Government Department.
8. The Tenderer have to deposit their **samples** of all articles at the time of opening of the Tenders, otherwise the offer shall be ignored.
9. 100% payment will be made on successful completion of the stores through the office of the District Accounts Officer, Multan against Receipt Certificate by the consignee.
10. The bidders are expected to examine the bidding documents/tender notice, including all instructions, terms and conditions, specifications etc. Failure to furnish all information/documents or submission of a bid not substantially responsive to the bidding documents/tender notice in every respect would result in the rejection of the bid.

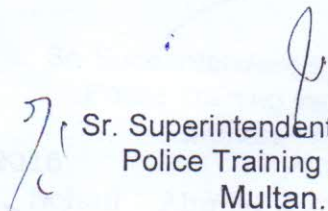
