Sub: Violation of Punjab Procurement Rules 2014, Chief Officer/ Chairman, Municipal Committee, Sarai Alamgir's Tender Notice for Cleanliness, Plantation and Construction Works.

Dear Sir,

This is with reference to Municipal Committee, Sarai Alamgir's Tender Notice, published in daily "Dawn" on 16th May, 2017. It is observed that the advertisement is in violation of the Violation of Punjab Procurement Rules 2014.

As per advertisement, 15 days of response time is not given and the last date for submission of tenders is on 26-05-2017, which is 4 days short. It is violation of Punjab Procurement Rules 2014, Rule No.14 (1). Stated as under;

14. Response time:- (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the complexity of the procurement, availability and urgency but, in no circumstances, the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No. 69, and with request to re-invite the quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.

Municipal Committee Sarai Alamgir invites tenders for the following development works from the contractors who are registered with Municipal Committee Sarai Alamgir and have deposited their registration fee for the year 2016-17. Tender form can be had from the office of Municipal Officer (Infrastructure). Tenders forms can also be downloaded from the website of Local Government & Community Development. As per Rule 50(4) of Works Rules 2003, all contractors must get receipt of Form-I prior to dropping tender. Tenders will be received in the office of Municipal Officer (Infrastructure) up to 12:00 noon of 26-05-2017 and opened the same day in the presence of tenderers or Tender Opening Committee at 02:00pm. The contractor will have to mention rates above or below Market Rates as per estimated cost. An earnest money of 5% as call deposit (issued by any scheduled bank) must come along with tender. Tenders without call deposit will not be issued. Conditional/dubious tenders will not be acceptable. The contractor who quotes rates further below than 4.99% will be bound to deposit performance security within a period of seven days. The contractor will be bound to start the work within one week of the work order and agreement. In case of non-compliance canceling the tender earnest money will be forfeited in favor of Municipal Committee Sarai Alamgir. Conditional/dubious tenders will not be acceptable. The approval/cancellation of tenders will be as per PPRA Rules 2014. Tender notice can also be visited on the website of PPRA.
