Sub: Violation of Punjab Procurement Rules 2014, Assistant Engineer, LG&CD, D.G Khan's Tender Notice for Miscellaneous Works.

Dear Sir

This is with reference to LG&CD, D.G Khan's Tender Notice, published in daily "Express" on 18th October, 2016. It is observed that the advertisement is in violation of the Punjab PRA 2014.

As per the advertisement, the tender fee for work is given as PRs 10,000/-, which appears costly in light of the Procurement Rule and is violation of Punjab Procurement Rules 2014, Rule 25(7). Stated as under:

25. Bidding documents.- (7) The procuring agency shall, on payment of such fee as the procuring agency may determine keeping in view the cost of printing and provision of the documents, provide a set of bidding documents to the prospective bidders.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 69, and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.

2. Tender will not be issued to those contractors whose performance of work remained unsatisfactory during the previous year or failed to complete the previous works.
3. Tender will be issued from the office of A.E, LG&CD,D.G.Khan upto 05.11.2016 till 12:00 PM on written application attached with earnest money equal to 3% of bid in form of CDR from any scheduled bank.
4. Tender will be received on 05.11.2016 at 01:00 PM and will be opened at the same date at 1:30 PM in the presence of Committee and contractor.
5. The Department will not responsible for supply of any machinery or material.
6. Any one or all of the bids can be rejected on the basis of evaluation criteria through Procuring agency on any grounds.
7. Estimated Cost and other information are available in the office of undersigned which can be seen during office hours with the Head Clerk.
8. The work will be executed as per provision in the T.S Estimate.
9. Rates quoted by the Contractors below than 5%, the contractor have to submit amount of difference as performance security in form of CDR within 15-days after the approval of rates, which will be returned to contractor on successful completion of work, otherwise work will be cancelled and earnest money will be forfeited.
10. The contractor would be eligible for issuance of tender who have valid PEC Certificate for the year 2016 or with original PEC Fee receipt for the year 2016.
11. Rejection of bidding the procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposals.
12. The procuring agency should upon request communicate to any bidder the grounds for its rejection of all bids or proposals but shall not be required to justify those grounds.
13. The work orders of development schemes will be issued after receiving of funds from the Govt.
